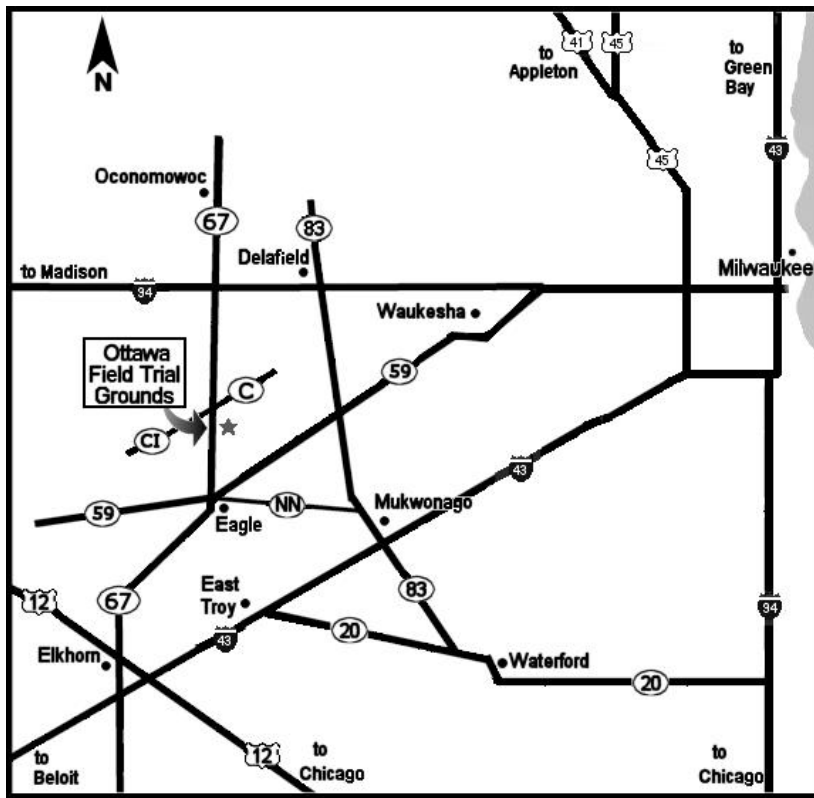
### DIRECTIONS TO OTTAWA FIELD TRIAL GROUNDS
