Horseback handling will NOT be permitted in any stake.

Amateur Hunting Dog is open to Pointers 6 months or older, and dogs are not required to be steady to wing and shot, but must establish point – they will be judged based on their style and usefulness as a personal hunting dog.

Dogs with major field trial wins in broke stakes may not enter this stake.
