Amateur Hunting Dog is open to Pointers 6 months or older, and dogs are not required to be steady to wing and shot but must establish point – they will be judged based on their style and usefulness as a personal hunting dog.

Dogs with field trial placements in broke stakes may not enter Amateur Hunting Dog.

Geriatric Gambol is open to all AKC Registered Pointers 8 years and over.
